### **Town Board Meeting Highlights**

## November 10, 2021

TownOfCaroga.com contains all issues of the Caroga News Flash.

This monthly meeting started at 7:00pm and lasted 126 minutes at Town Hall and via Zoom. Three members of the public attended at Town Hall, and fourteen families attended via Zoom.

Jeremy Manning gave a video presentation "Wheelerville Trails 2022-2025".

- The goal is to establish Caroga as the premier mountain biking destination in the region.
- By 2025, the trails will increase from 8 miles now to at least 20 miles for riding.
- Wheelerville Trails can help improve the quality of life in the Town of Caroga.
- The high quality trail project is a local-regional recreational and economic asset.
- The project has been funded with a NYS DEC Smart Growth Grant.

#### **Resolutions / Local Laws:**

- 1. Caroga Lake Volunteer Fire Company Robert Sullivan, Caroga Lake Fire Company President, spoke about changing the zoning of the old fire house in Wheelerville from conservation back to commercial. The Board waived any filing fees associated with the process outlined in Article 12 Section (II)(B) per the codes department (5-0 vote).
- **2. Golf Course** The course is now closed for the season. Extra beverages are being donated to the highway department (5-0 vote).
- **3. Budget Transfers** To maintain a balanced budget, transfers were approved (5-0 vote)
