Town Board Meeting Highlights

December 14, 2022

The monthly Board meeting at Town Hall and via zoom started at 6:00 PM and lasted 100 minutes.

The meeting included executive session for 30 minutes to discuss litigation against the Town (see leaderherald.com/gloversville-johnstown-local-news/2022/12/court-battle-will-decide-fate-of-caroga-petitions).

Resolutions / Local Laws:

- 1. Building Projects —
- Salt/Sand Storage Building at cell tower site was completed with funding from fire insurance.
- The Board amended Phinney Design Group's contract with hourly rate, not to exceed \$4,000.00: (a) to design electrical service for the future Town Barn DPW garage at the cell tower site and (b) to put together a bid document to be used for public bidding for construction (5-0 vote).

(Questions remain about how the Board can pay for Town Barn and Golf Storage/Maintenance Building projects, given that no referendum election approved bond resolutions and given that no 2023 capital budget allocated fund balance for such projects.)
