AGREEMENT

BETWEEN THE TOWN OF CAROGA AND COUNTY OF FULTON FOR PLANNING SERVICES

THIS AGREEMENT was entered into this 1st day of January 2022, by and between the Town of Caroga (hereinafter referred to as "TOWN") and the County of Fulton (hereinafter referred to as "COUNTY").

WITNESSETH

WHEREAS, the TOWN desires the COUNTY to provide services from the Planning Department during 2022;

NOW, THEREFORE, the parties hereto mutually agree as follows:

ARTICLE I PLANNING SERVICES

The COUNTY shall provide the following services by the County Planning Department to the TOWN:

- 1. Land use planning guidance and assistance.
- 2. General planning services.
- 3. Any other planning services that may be requested by the TOWN.

ARTICLE II COMPENSATION

- 1. The TOWN shall compensate the COUNTY in an amount not to exceed \$1,500.00 in 2022 for Planning Services.
- 2. The COUNTY shall bill the TOWN on a quarterly basis during 2022 for Planning Services.
- 3. The TOWN shall be billed only for the actual number of hours spent by the COUNTY performing work tasks for the TOWN under this Agreement. The billing rates for the COUNTY shall be the 2022 hourly rates for the Planning Department staff person providing the services to the TOWN.
- 4. The COUNTY shall provide the first ten (10) hours of service at no cost to the TOWN.

ARTICLE III RECORD KEEPING

- 1. The COUNTY shall maintain detailed records documenting the number of hours worked related to this Agreement.
- 2. Upon request, the COUNTY shall make said records available to the TOWN for review.

ARTICLE IV MISCELLANEOUS

- 1. The COUNTY agrees that it will comply with all federal, state and county laws, rules, regulations, codes and ordinances on its part to be complied within the performance of this Agreement.
- 2. Any disputes regarding scope of services, work performance, payments or any other shall be resolved by mutual agreement between the Fulton County Planning Director and the Supervisor of the Town of Caroga.
- 3. All proposed changes to the scope of work or total compensation shall be resolved by the mutual agreement of the Fulton County Planning Director and the Supervisors of the Town of Caroga.
