A local law TO ESTABLISH THE OFFICE OF A SINGLE APPOINTED ASSESSOR IN  
THE TOWN OF CAROGA, FULTON COUNTY, NEW YORK

SECTION I TITLE  
A. The title of this Local Law is "A Local Law to Establish the Office of a Single Appointed Assessor in the Town of Caroga, Fulton County, New York"

SECTION II STATUTORY AUTHORIZATION AND PURPOSE  
A. This local law is to establish the office of a Single Appointed Town Assessor for the Town of Caroga, New York.  
B. Statutory authority to establish the office of a Single Appointed Town Assessor for the Town of Caroga is Title 2 of the Real Property Tax Law entitled "Assessors and Assessor Training".

SECTION III GENERAL PROVISIONS  
A. The Town Board of the Town of Caroga adopted Local Law No. 1 of the year 1971 entitled "A Local Law To Provide for Retention of the Elected Assessors in the Town of Caroga".  
B. The Town Board of the Town of Caroga hereby repeals Local Law No. 1 of the year 1971 and hereby terminates the term of all Town Assessors in office on the effective date of this Local Law.  
C. The Town Board of the Town of Caroga hereby establishes the office of a Single Appointed Assessor for the Town of Caroga within the meaning of Section 310 of the Real Property Tax Law.  
D. That within the meaning of Section 310 of the Real Property Tax Law the term of office for the Single Appointed Town Assessor for the Town of Caroga, shall be six (6) years and shall commence on the first day of October, 1987, and each sixth year thereafter.

SECTION IV EFFECTIVE DATE  
A. This Local Law is subject to a permissive referendum and shall become effective on compliance with all of the provisions of the Municipal Home Rule Law applicable thereto and upon the filing hereof with the Secretary of State.
