A local law TO REPEAL LOCAL LAW NO. 1 for 1985 (ALTERNATIVE VETERANS

EXEMPTION -OPTION TO NOT GRANT EXEMPTION) and ADOPT PROVISION OF SECTION 458(a) OF THE REAL PROPERTY TAX LAW.

Town Be it enacted by the Town Board of the Town of Caroga as follows:  
Village Section 1. The purpose of this law is to repeal Local Law No.1 for 1985 entitled ALTERNATIVE VETERANS EXEMPTION - OPTION TO NOT GRANT EXEMPTION and to adopt the provisions of Section 458(a) of the Real Property Tax Law which provides a limited exemption from real property taxes for real property owned by persons who rendered military service to the United States, provided such property meets the requirements set forth in the law.

Section 2. The alternative veterans exemption from real property taxes shall be granted pursuant to Section 458(a) of the Real Property Tax Law with the following statutory maximums as set forth below:

War Veteran - 15% of assessed value to a maximum of: \$12,000  
Combat Zone Veteran - 10% of assessed value to a maximum of: \$ 8,000  
Disabled Veteran % of assessed value 1/2 of service-connected disability rating to a maximum of: \$40,000

Section 3. This local law shall take effect immediately upon its filing with the Secretary of State.
