### 1. DANGEROUS DOGS PROHIBITED:

No person shall permit any dog to be at large on any street or public place in the Town of Caroga if such dog is ferocious, vicious or habitually attacks, injures or damages persons, domestic animals, domestic pets or property.

## 1. PENALTIES FOR OFFENSE:

Any person violating any provision of this Article may be punishable by a fine of not less than \$50.00 nor more than \$250.00 or imprisonment for a period not exceeding 15 days.

#### 3. NON-EXCLUSIVE REMEDY

Nothing in this law shall prohibit a complainant from filing a complaint about a dangerous dog under Article 7, Section 121 of the Agriculture and Markets Law of the State of New York.
