Section I. Section 922 of the Real Property Tax Law provides the form and content of the statement of taxes to be mailed to each owner of real property.

Section II. Given that on October 8, 2014 Local Law #2 Amanda's Law a Law Regulating Ice Shanties in the Town of Caroga was enacted, the purpose of this local law is to contribute to the safety of all who recreate or traverse the frozen lake waters within the Town of Caroga during the Ice Fishing Season.
