Town Board Meeting Highlights

May 8, 2024 Monthly Meeting

TownOfCaroga.com contains all issues of the Caroga News Flash.

This monthly meeting began at 6:30 PM and lasted 60 minutes, including 5 minutes in executive session for personnel. Residents attended at Town Hall, and 20 families participated via zoom.

Resolutions:

- 1. Public Hearing: Restore NY Grant Application for Project at 2144 State Highway 10 —
- Mr. Scott Horton described the grant "purpose of revitalizing urban centers, rural area, disadvantaged communities, and stabilizing neighborhoods." He aims to refurbish his Shutts' Garage property "for retail lease, to reduce blight, and to bring life to Town Center."
- Eligible applicants include any NYS County, City, Town, or Village. The Town of Caroga is named as applicant. Terms of required 10% matching funds were not discussed publicly.
- The Town Board accepted Mr. Horton's \$500.00 donation to cover the Town's payment to Empire State Development Corporation for the \$500.00 grant application fee (5-0 vote)
- The Board approved a budget adjustment for Mr. Horton's donation and the grant payment From: A2705 Gifts and Donations \$500.00 To: A1010.41 Grant Writing C/E \$500.00 and approved \$500.00 payment to Empire State Development Corp. (5-0 vote)

2. Comprehensive Planning Committee —

- After receiving letters of interest from Doug Purcell, Dave Cummings, Jeremy Manning, Rachel Simonds, and Anita Long, the Board deferred appointments until the June meeting.

3. ProcellaCOR Project —

- On May 16, the APA approved a permit with conditions. They questioned Caroga's decision to treat only 3 sites (i.e., postponing the 4th Turtle Bay site). ProcellaCOR treatments at the Campsite, East-West Channel, and West Caroga Mead Creek are planned in early June.

Town Board Meeting Highlights

May 2024 Grants Funded in the Town of Caroga

The Town of Caroga was awarded a 2024 \$99,700.00 **NYS DEC Smart Growth Grant** to fund Wheelerville Trails Phase 2.

This project will expand existing trails and create new routes accessible for a broader audience, particularly beginner and intermediate level mountain bike riders.

The Town of Caroga has \$241,739.81 to fund 2024 road paving.

This includes rollover plus a \$114,367.44 grant from the NYS Consolidated Local Street and Highway Program (CHIPS), \$26,394.21 from PaveNY, \$23,391.00 Emergency Recovery, and \$17,533.66 Potholes Grant. Paving is planned on Vrooman Road, North Shore, Everson, Kirchen Grove, Garlock, North Bush, and spots on South Shore East Caroga.

Caroga Arts was awarded a 2024 \$850,000.00 **New York State Council for the Arts (NYSCA) Grant** to support MyHill.
